Tuition Payment Options: Families have the option to pay tuition Annually, Semi-Annually, or Monthly. Annual payments are due July 2024; Semi-Annual payments are due July 2024 and January 2025; Monthly - divided equally from July 2024-May 2025

Extended Care

K-12th grade students are able to stay for extended care services. Extended care rates are as follows:

Extended care rates are \$10/day, per student until 5:15pm. Extended care rates are only charged if a student is checked into extended care. There is not a pre-registration process.

Late Fee for Extended Care is \$1 per minute after 5:15pm and is automatically charged by FACTS according to the student's check-out time in the system. Extended Care charges are billed through the FACTS financial portal the following week after charges occur.

Withdrawal Procedure and Fee

Withdrawal Fees are in effect on the day that the student's registration is completed.

SCA has many expenses of a continuing nature, including faculty salaries and campus costs, that are covered through annual income from tuition. Because of these expenses, SCA relies on its families to uphold the financial agreement signed at registration time. This includes paying the withdrawal fee and the prorated tuition for the days the student was enrolled. **Withdrawal Fee:** \$500 per student

Procedure:

1. The registering parent/guardian must complete a withdrawal form stating the student's last day of attendance (withdrawal forms are available in the school office).
2. Parent/guardian's FACTS financial account will be billed the prorated tuition and withdrawal fee based on the student's last day of attendance.
3. Student records will be released from the school when the student's financial account is settled.
